Physical Platinum ETC

GPF Physical Platinum is designed to offer security holders a simple and cost-efficient way to access the platinum market by providing a return equivalent to the movements in the platinum spot price less the applicable Total Expenses Ratio (TER). GPF Physical Platinum is backed by physical allocated platinum. Only metal that conforms with the London Bullion Market Association's (LBMA) rules for Good Delivery can be accepted by the Custodian. The ETC securities (or "ETCs") are backed by exclusive title to a specific pool of physical bars held in segregated accounts. Each bar is individually identified and allocated.

Replication and Pricing

GPF Physical Platinum ETCs are backed by a direct investment in the underlying physical platinum. Authorised participants create and redeem GPF Physical Platinum ETC securities by delivering or receiving platinum that conforms to LBMA Good Delivery standards. The issuer has direct and sole ownership of the platinum, which is stored in secure vaults in London or Switzerland. Each physical ETC security entitles the holder to a specified quantity of platinum (the "Metal Entitlement") of the segregated pool owned by the issuer. The value of the security is a function of the Metal Entitlement, the platinum spot price and any applicable fees.

- **Responsible Sourcing:** LBMA approved and sourced metal and a commitment to the UN Sustainable Development Goals 2030

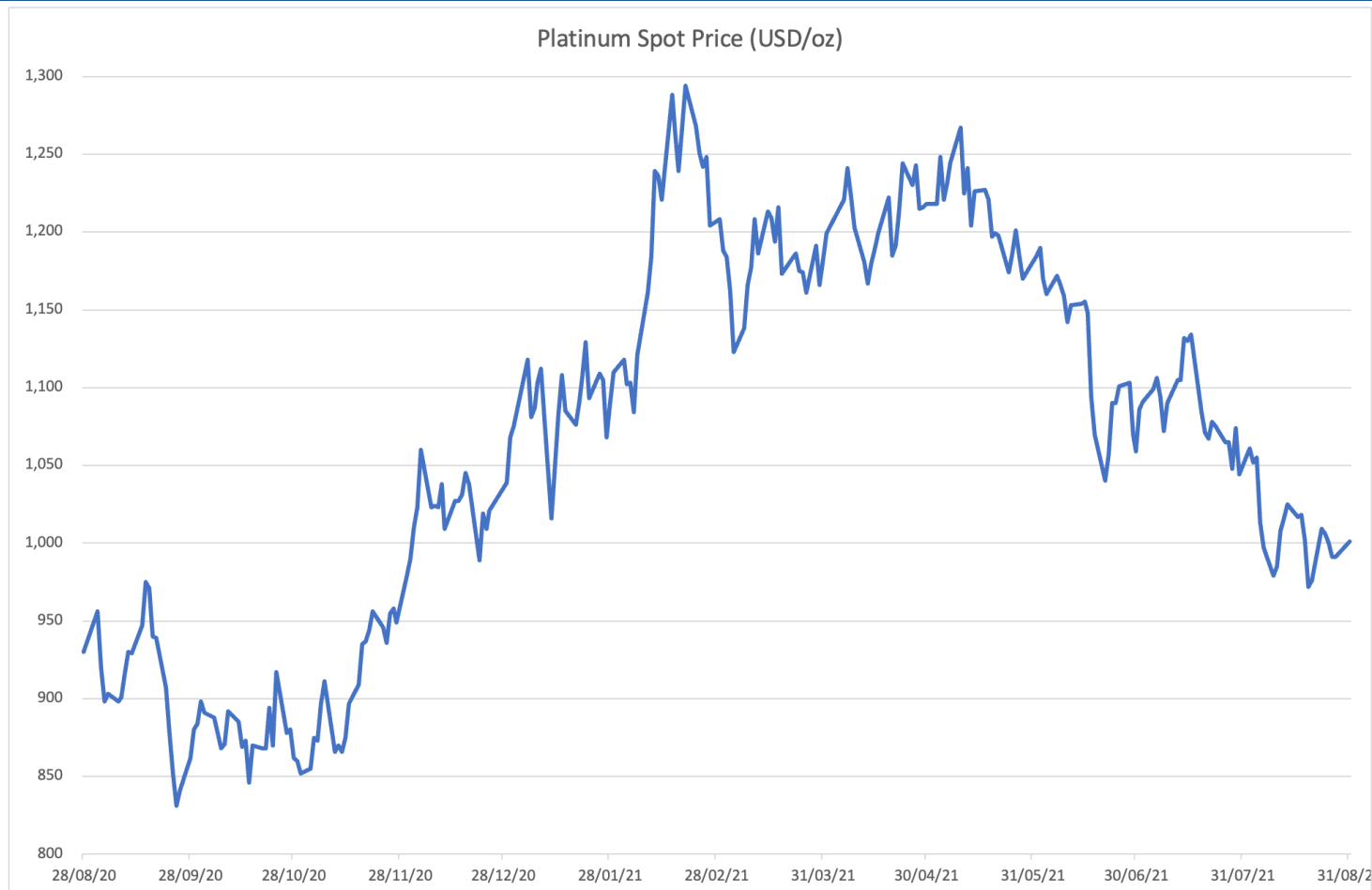
